IN-STUDIO WAIVER OF LIABILITY

All Participants at Jhoon Rhee TKD whether adults or minors through their parents and/or guardians, represent that they are in good physical condition of a level that is sufficient to participate in exercise, martial arts and other offered programs and to use any equipment provided therein. Further, Participants acknowledge that Jhoon Rhee TKD’s personnel, while well-trained to provide exercise programs and instruction, do not have expertise or responsibility to determine a Participant’s physical condition, to diagnose, examine, or treat medical conditions of any kind or to determine the effect of any specific exercise or instruction on any Participant and/or his/her medical condition. By participating in any of Jhoon Rhee TKD’s offerings, Participants acknowledge and agree (if over the age of 18 for themselves, or if under 18 by their parents on their behalf) that there is the possibility of accidental or other injury and explicitly assume the risk of any injury; and further agree to indemnify Jhoon Rhee TKD, its owners (Barry Shackelford and Francis Pineda), its employees, volunteers or agents from any and all liability on the part of Jhoon Rhee TKD relating to their participation.
